Virginia Recognizes 25 Mines for Excellence in Worker Safety

Virginia coal industry is fatality free for third consecutive year

Big Stone Gap, Va. – The Virginia Department of Mines, Minerals and Energy (DMME) awarded coal mines in the Commonwealth for no injuries on their sites in 2017. Thirteen miners were also recognized with individual awards for working decades without injury.

“Safety is our first priority,” said Virginia Division of Mines Chief Randy Moore. “We continue to invest our resources making sure Virginia’s coal miners are safe.”

Virginia’s Coal industry had no fatalities for 2017, 2016 and 2015 a commendable achievement. “Three years of no fatalities lets us know our people and programs in our coal mine safety division are doing their jobs well,” said DMME Deputy Director Butch Lambert. “This is an achievement DMME is proud to announce”.

Virginia Coal Mine Safety Awards are presented on behalf of the Virginia Coal Mine Safety Board and the Department of Mines, Minerals and Energy. These awards publicly recognize outstanding safety achievements in the state’s coal mining industry.

Special safety awards will be considered for consecutive years without a lost time injury by individuals or operations, or other outstanding individual achievements in promoting mine safety.
